
FIRM CAPITAL currently has approximately \$2 billion in mortgage and real estate related investment assets under management plus the associated investor capital under management.

Firm Capital is the Mortgage Banker to various capital pools, including the Toronto Stock Exchange listed Firm Capital Mortgage Investment Corporation (TSX: FC), Firm Capital Mortgage Investors Corporation, a private mortgage RSP fund in operation since 1994, and Firm Capital Private Mortgage Trust, a fund designed for investors wanting alternative investments. In addition to completing a number of new joint venture capital partnerships, Firm Capital completed over \$793 million in 2015 and \$480 million year to date in 2016.
