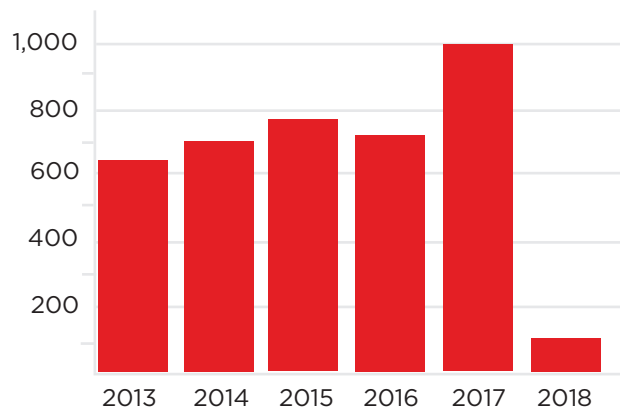
Administering a \$1,330 million portfolio, Firm Capital is the Mortgage Banker for various capital pools, including: the Toronto Stock Exchange listed Firm Capital Mortgage Investment Corporation (TSX:FC) with a market capitalization of \$338 million and seven listed Convertible Debentures totaling \$163 million; and Firm Capital Mortgage Investors Corp., an RSP mortgage fund in operation since 1994. In addition to completing a number of new joint venture capital partnerships, Firm Capital completed over \$1 billion of new mortgage financing commitments in 2018.

- Principal Philosophy: Preservation of Capital and Disciplined Investing.

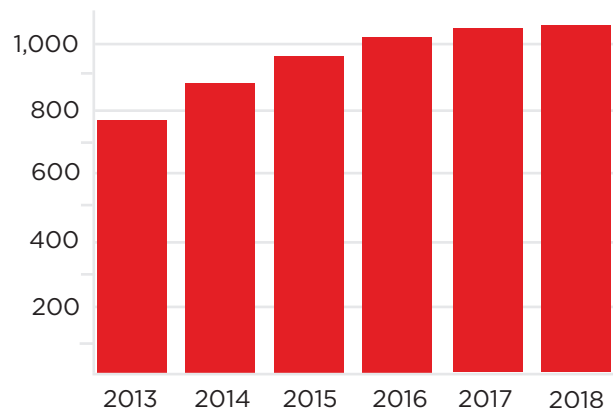
### COMMITTED MORTGAGE TRANSACTIONS
