
## **FIRM CAPITAL CORPORATION** FACTSHEET NOVEMBER 2021



#### **INVESTMENT HIGHLIGHTS**


**Firm Capital Corporation ("Firm Capital")** a non-bank lender since 1988 provides residential and commercial construction, bridge and conventional real estate financing, including providing term, mezzanine and equity capital investments for real estate projects.

Administrating a \$1,296 million portfolio, Firm Capital is the Mortgage Banker for various capital pools, including: the Toronto Stock Exchange listed Firm Capital Mortgage Investment Corporation (TSX:FC) with a market capitalization of \$465 million and seven listed Convertible Debentures totaling \$185 million; and Firm Capital Mortgage Investors Corp., an RSP mortgage fund in operation since 1994. In addition to completing a number of new joint venture capital partnerships, Firm Capital completed over \$560 million of mortgage financing commitments in 2020 with YTD 2021 commitments of \$980 Million.
