## FIRM CAPITAL PROPERTY TRUST ANNOUNCES CLOSING OF PREVIOUSLY ANNOUNCED ACQUISITION OF \$6.3 MILLION QUEBEC INDUSTRIAL PROPERTY

Toronto, Ontario March 21, 2022. Firm Capital Property Trust ("FCPT" or the "Trust") (TSX: FCD.UN) is pleased to announce the closing of its previously announced acquisition of a 50% interest in a multi-tenant industrial property located in Saint Laurent, QC (the "Property"). The acquisition price for 100% of the Property was approximately \$6.3 million (\$181 per square foot), excluding transaction costs.

The Property totals 34,612 square feet and is in close proximity to the Trust's Montreal Industrial Portfolio. The Property is 100% occupied and accretive to AFFO.

The Trust acquired the Property such that the Trust owns 50% and private clients affiliated with certain members of senior management and the board of trustees of the Trust owning the remaining 50% in a side-by-side alignment of interest structure. The Trust's portion of the acquisition price was approximately \$3.15 million (excluding transaction costs). The Trust financed a portion of the acquisition through existing cash resources (including the Trust's credit facility).
