


## **High Quality Portfolio**

#### **Investment Portfolio**




#### **Geographic Diversification\***



\*(excluding 14 Related Debt Investments totaling \$60 million)




## **Annualized Return on Shareholders' Equity**

### A \$100 investment in 1999 would be worth \$821










### Mortgage Portfolio, Repayments & New Investments
